COVID-19 Friday, April 3rd Update

Another busy week with lots of changes coming ahead. Thankfully, we are still very fortunate with low cases of COVID-19 and we do hear that the "Safer at Home" orders are helping to flatten the curve. We also are hearing that we may see an influx in the next few weeks, so all need to continue to do our part and abide by the social distancing. The Ashland Chamber along with Washburn, Bayfield, and Madeline Island Chambers authored a letter to the city of Ashland to ask that the beaches be closed for smelting. Smelting usually takes place the third to fourth week in April and we felt very strongly that the folks coming to this area are coming from many of the hot spots in Wisconsin and Minnesota. I consider myself one of the best ambassadors and cheerleaders for tourism promotion, but my concern for the health and wellbeing of our communities is greater.
