# Ashland, WI a "Superior" Sporting Destination

No matter how many places we travel to hunt or fish, the list of dream destinations never seems to get any shorter. travel when and where we can, but outdoor plans and passions are too often trumped by our thinning wallets or the thickening storylines of our daily lives.

I had edited some film from Ashland, but had never actually visited the little Lake Superior city prior to last month's Association of Great Lakes Outdoor Writers (AGLOW) conference. I spent a week there and soon learned what I'd been miss-

ing.

The City of Ashland is an easy and scenic nine-hour drive from Northern Indiana and is best-known, perhaps, for its out-

Ashland is located on Chequamegon Bay (pronounced SHE-WAH-ME-GONE), a shallow arm of Lake Superior protected by the picturesque Apostle Islands. The bay's habitat and forage are

ideal for growing trophy smallmouth bass and walleye, as well as supporting sporty brown trout and other visiting salmonid

But Ashland anglers don't live by the bay alone.

Diversity is one of the characteristics of any true angling hotspot. When it comes to fishing, it is certainly good to have a backup plan. And Ashland has them in spades.

Many of the world's best muskie waters are found within an hour's drive of Ashland, so when the wind kicks up on the bay, anglers simply change gears and cast for a different kind of trophy. These same inland lakes and flowages offer exceptional opportunities for bass, walleye pike, sturgeon and panfish as well. Finally, many of the area's streams and rivers support populations of native trout, while others host seasonal runs of Lake Superior steelhead and salmon. Bring your own boat, or book in advance with one of the area's quality fishing guides. You can't go wrong here.

When Outdoor Life named Ashland, Wisconsin number 27 in its list of the 200 best towns in America for hunters and fishermen a couple months ago, their decision wasn't based on fishing alone. Their formula took hunting opportunities into consideration as well, along with a variety of factors contributing to an overall high quality-of-life.

Those considering Ashland as a hunting destination will find ample opportunities for ruffed

grouse, woodcock, whitetail deer, wild turkey, waterfowl and black bear on over one million acres of public ground. And should you decide you need them, the Ashland area supports a healthy stable of experienced hunting guides who will help put you on the game.

People often make the difference in our decision-making and the quality of our outdoor experiences, and it is no exaggeration when I say that everyone I met in Ashland was simply fantastic.

The Americann Hotel and Conference Center served as our headquarters at the AGLOW con-ference, and I recommend it to anyone coming to Ashland. The rooms are clean and reasonably priced and they have a nice continental breakfast (including biscuits and gravy), but the view is the main attraction. The AmericInn sits right on the bay, so make sure to request a lakeside room when making your reservation. Bringing your kids along? The Americann has an awesome little indoor waterpark that will keep them happy and occupied for

If you need some help on the fishing front, renown fishing guide, Capt. Roger LaPenter and his wife Carolyn have their shingle hung out just steps from the Americann. Their shop, Anglers All, will provide you with every-thing you need to make the absolute most of your time on the water. Roger guides on Chequamegon Bay for trophy smallmouth bass and a variety of inland lakes and flowages for muskies and other species. He is a fly fishing specialist, but uses

all manner of tackle.

While I've only just returned from Ashland, I'm already mak-ing plans to return. Mary, Maribeth and JoAnn at the Ashland Area Chamber of Commerce helped me make the most of my first visit to the Ashland area and they'll do the same for you. 
