Race Course and time: Start line is located behind the Bretting Community Center in the Central Railyard Park. Start time is at 10am

#### For safety purposes:

Everyone participating must be a paid participant of the race wearing an official bib or they will be directed to leave the course. NO animals, roller skates, roller skis, inline skates or bikes are allowed to participate in the Bay Days Fun Run. For your own safety and for those around you, these are NOT allowed. If you are caught on the course with any of these, you will be directed off the route. In 2023 we are testing the waters and allowing Strollers & Carriages to participate in the Chick-uamegon, we just ask that the folks with strollers line up in the back and don't take up the whole trail. The chick-uamegon is an out and back course.
